Parental / Guardian Permission to Ride the Church Bus

1. We are an independent Baptist Church. We, Gospel Light Baptist Church, believe the Bible is the Word of God.
2. Our purpose as a Bible-believing Church in regards to your child: (Matthew 28:19-20)
 - a. *To Present the Gospel*
 - We are all sinners (Romans 3:10).
 - The price for sin is to die and spend eternity in hell (Romans 6:23).
 - Jesus died to pay for our sin, and provide a way to Heaven (Romans 5:8).
 - Anyone who will call on Jesus and trust Him to be saved, will be saved and be destined to go to Heaven (Romans 10:13).
 - b. *To Teach About Baptism*
 - Baptism is a step of obedience to God that comes after salvation. It is done by immersion and is one of the first things that a Christian is commanded to do.
 - If a parent/guardian wishes for his/her child to be baptized there must be a separate permission slip filled out and the procedure explained.
 - c. *To Teach the Bible*
 - Our programs, the preaching, the Sunday Schools, etc are designed to teach the Bible. We believe that obedience to the principles and truths of the Bible will help a person to live a purposeful, fuller, and more joyful life, as well as to develop a personal walk with God.

In the event any disagreement or conflict arises from any activity connected to this authorization and release, I knowingly and expressly agree to have such conflict resolved in accordance with the Binding Arbitration procedures developed by Gospel Light Baptist Church, and agree to be bound, expressly waiving any and all rights in law and equity to bringing any civil disagreement before a court of law.

In the event of a medical emergency and I cannot be reached, I hereby authorize Gospel Light Baptist Church and its agents to make emergency medical decisions for my child.
